Introductory statement

Oasis Academy Limeside is an academy where all young people are given the opportunity, they deserve to make excellent progress and fulfil their full potential. Oasis academy Limeside is a fully inclusive primary academy, accepting children of all abilities, of any faith or none.

Admission number(s)

The school has an admission number of 60 for entry in reception.

The school will accordingly admit this number of students if there are sufficient applications. Where fewer applicants than the published admission number(s) for the relevant year group are received, the academy trust will offer places at the school to all those who have applied.

Application process

Arrangements for applications for places to Reception at the academy will be made in accordance with Oldham Local Authority's co-ordinated Admission arrangements and will be made on the Common Application Form provided and administered by Oldham Local Authority.

The process of allocating places will begin after 15th January. You will be sent a letter or email from Oldham Local Authority on 17th April.

Oversubscription criteria and Tie Break

When the school is oversubscribed, after the admission of students with an Education, Health and Care plan or a Statement of Special Educational Needs naming the school, priority for admission will be given to those children who meet the criteria set out below, in priority order:

1. Looked after children and children who were previously looked after but immediately after being looked after became subject to adoption, a child arrangements order, or special guardianship order. This includes those children who appear to Oasis Community Learning to have been in state care outside of England and ceased to be in state care as a result of being adopted. Previously looked after children are children who were looked after but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order).
2. Children for whom the Academy is appropriate on genuine medical or social grounds. Such applications will be decided by the Academy Council or nominated panel. (Applications on medical grounds will only be considered under this criterion if they are supported by an attached written statement from a doctor or other relevant healthcare professional. Evidence for social grounds must be presented in writing from a social work professional. All applications must demonstrate that there is a very

specific connection between the child's medical/social need and the Academy requested).

3. Children who will have a sibling attending the school at the time of their admission. Included in this criteria are siblings (step-brothers and sisters and half-brothers and sisters) living at the same address and who will be attending the school at the expected time of admission.
4. Children who live closest to the school. The distance will be determined by measuring the shortest available route using the public road network from the pupil's home to the main school gate, as determined by the LA. The distance will be measured by using a computerised geographical information system (GIS). Priority will be given to those living nearest to the school using this system. Pupils living in flats where the distance measures the same, priority will be given in ascending order of flat number/letter/floor.

Tie Breaks

If there are more applicants than there are places remaining within a particular category, random allocation will be used to allocate the final available place(s). Random allocation process will be independently verified.

Late applications

All applications received by Oldham Local Authority after the deadline will be considered late applications. Late applications will be considered after those received on time. If, following consideration of all applicants the school is oversubscribed, parents may request that their child is placed on the school's waiting list.

Admission of children outside their normal age group

Parents may request that their child is admitted outside their normal age group. To do so parents should include a request with their application, specifying why admission out of normal year group is being requested, and the year group in which they wish their child to be allocated a place.

When such a request is made, the academy trust will make a decision on the basis of the circumstances of the case and in the best interests of the child concerned, taking into account the views of the principal and any supporting evidence provided by the parent.

About our nursery

Oasis Academy **Limeside** is a nursery where our young people are given the care, support, and opportunity to develop and grow in a safe and encouraging environment and prepare for their step into life at school. Oasis Academy Limeside is a fully inclusive provision, accepting children of all abilities, of any faith or none.

Age range

Oasis Academy Limeside has classes for both 2-year-olds and 3-year-olds which your child would typically start the term after their 2nd or 3rd birthday.

Admission number(s)

The nursery has an admission number of 39 3-year-olds and 17 2-year-olds.

The school will accordingly admit this number of children if there are sufficient applications.

All places are term time only, places can be morning, afternoon or full day.

Application process

If you are a Parent or Carer and wish to apply for a place in our two-year-old and three-year-old Nursery at Oasis Academy Limeside, you will need to complete our Application Form available on our website or from our reception. Please note that children who have a place in our nursery do not automatically move into our Reception classes. Parents and Carers must apply for a Reception place for their child via Oldham Local Authority's admissions service.

Applications are open throughout the year, please speak to the school office for an application form. Children will be put onto the waiting list and places will be offered during the half term before the place becomes available.

Funding

For two-year olds - Depending on your circumstances, you may be eligible for free childcare.
